Certification Nos: ANZEx 13.3002; IECEX TSA 13.0005X

CMI Electrical are notifying the industry that minor documentation issues have been identified with Certification Drawings for the above products.

This issue will require a supplementary certification to correct some information on the drawings for these products.

This will take place over the next month and revised drawings will be available on the CMI Electrical website when they are issued.

During this investigation, we had the products fully assessed by our certification body, TestSafe, and they have issued the following statement:

"I wish to confirm that we have reviewed the information provided, the relevant certification drawing and the associated manufacturing drawings related to the product covered by the above certificate.

The product was tested and passed all tests as required by IEC 60079-0 and IEC 60079-1. There is no safety issue identified with the product.

However, there are discrepancies on the certification drawing which will require a supplementary certificate to be issued to correct it."

Note:

We have become aware of unsolicited information circulating in the industry that these products have a major non-compliance.

This is un-true, refer to the above statement from TestSafe.

This type of information can disrupt confidence in both products and manufacturers.
